The main duties and responsibilities of this role include:

- Manage the relationship between the Securities Commission and the Centre, including organisation of the SC-OCIS roundtable and the SC-OCIS visiting fellowship programme.
- Co-lead a research agenda that contributes to the study of Islamic Financial Markets, as well as the broader agenda on impact investing, sustainability, and economic and social governance.
- Stay abreast of regulatory changes, policies, and initiatives in finance, environmental mitigation, and adaptation.
- Develop links with policymakers, regulatory agencies, and financial institutions (both traditional financial institutions, as well as non-bank financial intermediaries such as FinTech firms).

- Share responsibility for the design of ongoing and future research and preparing applications for extramural grants for projects.
- Share responsibility for fundraising and partnership development with financial institutions.
- Representing the Centre at external meetings/seminars.

Selection criteria

- Ideally a doctoral degree in Economics, Finance or related fields with significant research experience
- Experience in the financial sector / regulation (desirable).
- A strong understanding of capital markets and financial regulations.

- Strong writing skills, with experience in preparing policy reports, etc.
- Familiarity with the existing literature and research in the field.
- Sufficient specialist knowledge in the discipline to develop projects and methodologies.
- Ability to independently plan and manage a research project.
- Ability to raise programme and research funds from extramural sources.

About the Centre

The Oxford Centre for Islamic Studies is incorporated by Royal Charter and is registered as a charity (number 293072). The Patron of the Centre is HM King Charles III.

The Centre was founded in 1985 and is committed to the advancement of academic excellence in teaching, research and publication. The Fellowship is drawn from a variety of academic disciplines including anthropology, Asian and Middle Eastern studies, development studies, history, theology and religion, and science and society.

The research profile is similarly diverse, ranging from regionally based study of the intellectual roots of Muslim civilisation and contemporary social movements in the Islamic world to investigations into the theory and practice of Islamic financial management, and relationships between science and Muslim societies.

The Centre has a thriving publications programme, which includes the *Journal of Islamic Studies*, which has been published three times a year by Oxford University Press since 1990. It aims to encourage interaction among academics from diverse traditions of learning to enable the dissemination of their research and reflections. The Centre also facilitates, and actively encourages, the publication of monographs and other works by Centre Fellows.

The Centre's Library provides valuable and unique resources. It houses approximately 49,000 volumes and 360 manuscripts. The library collection is fully searchable on SOLO, the Oxford University's online library catalogue.

The Centre occupies purpose-built premises on a 3.25 acre site on the Marston Road, Oxford.
